BACK IN NORWAY, I WAS EXPERIMENTING WITH SAPA BIONS. ONE OF MY MANY DISCOVERIES

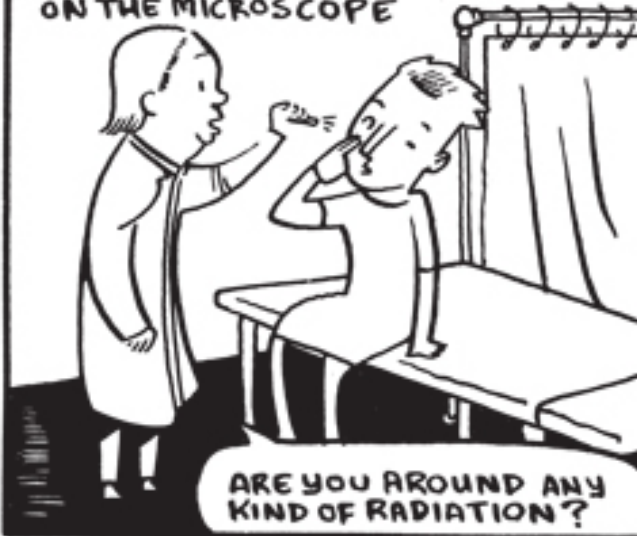

I FOUND THAT SAPA BIONS GAVE OFF A RADIANT BLUE ENERGY

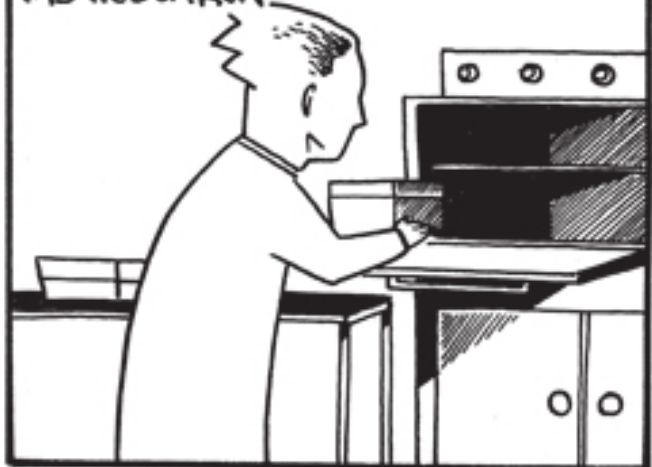

UNEXPECTEDLY, THE CONTROL BOX EXHIBITED THE SAME BLUE GLOW

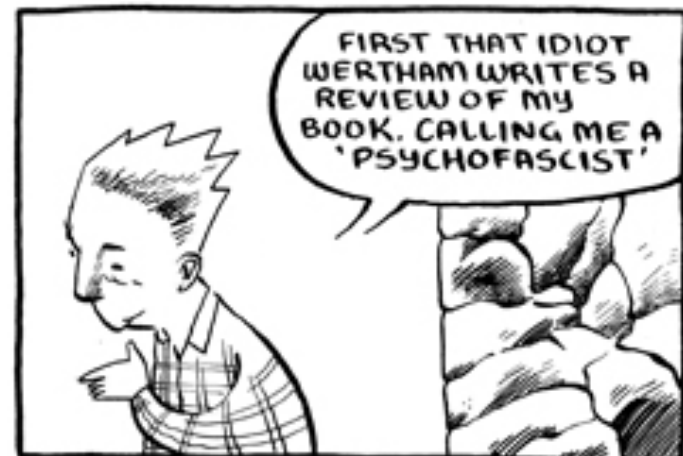
I REPEATED THE EXPERIMENT SEVERAL TIMES WITH THE SAME RESULTS



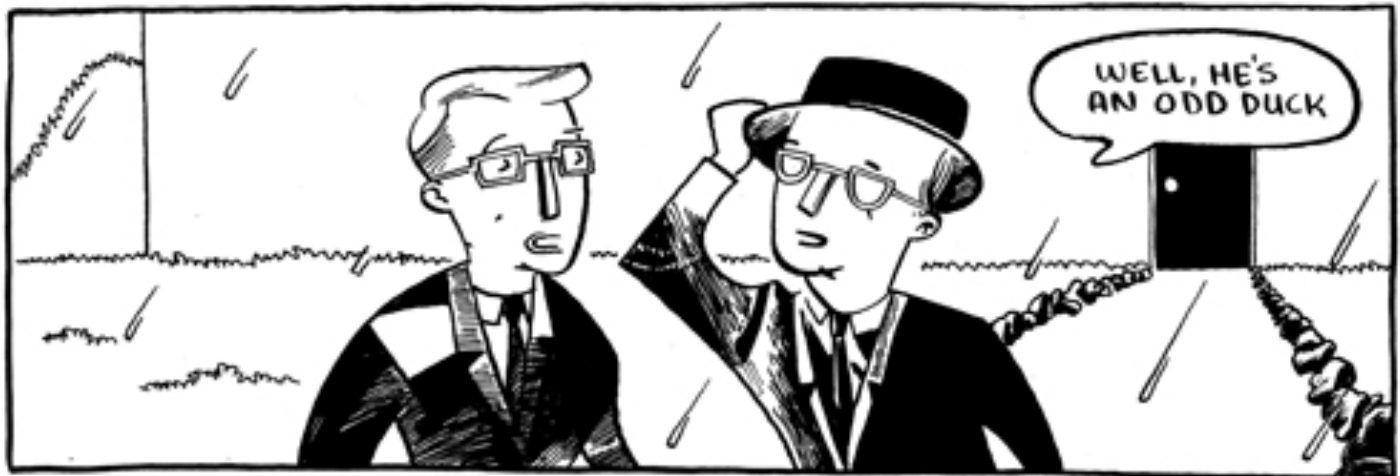
